Property owners Donald and Brenda Rivera came before the Board to discuss their property at 200 Washington. They stated they had been issued a warning from Code Enforcement Officer Stegmaier. After discussion, the Board granted the Rivera's 180 days to make improvements to bring the property into compliance.

Attorney Report

Mr. Parikh stated he had nothing to add. He did notify the Board that the State did not extend the deadline for adoption of the 2025 edition of the Colorado Wildfire Resiliency Code. The Board will need to take action by the June meeting. There were no questions from the Board for Attorney Parikh.

Town Administrator Report

Administrator Rapp notified the Board that the Town was awarded a grant from Representative Bobert but the amount of the award has not been announced and we have not heard back on the grant that was submitted to Representatives Hickenlooper and Bennett. Working on getting bids to get a bathroom in the park. Summer Youth Baseball has 90 kids registered. Working with different vendors to get the school and Town of Ramah baseball fields ready for use. There were no questions from the Board for Administrator Rapp.

Building Official/Code Enforcement – in packet

Resolution 409-2026 – Reappointment of Town Officers

Trustee vanZoeren moved to reappointment, Jacquelyn Rapp as Town Administrator, Megan Taunton as Town Clerk/Treasure, Andrew Kissam as Chief of Police and Hoffmann, Parker, Wilson & Carberry as Town Attorney, Trustee Ivanovic second, Mayor Fulmer called for discussion, none, motion passed.

Resolution 410-2026 – Reappointment of Stephen Jones as the Town Municipal Judge and approving Municipal Judge Agreement

Trustee Nipple moved to reappoint Stephen Jones as the Town Municipal Judge and approved the Municipal Judge Agreement, Trustee Billmire second; Mayor Fulmer called for discussion, none; motion passed.

Judge Jones spoke to the Board about the efforts of the Court staff and Police Department. Said court is moving in a great direction.

Approval of Revocable License Agreement with Crossroads Youth Works

This agreement is in regard to the use of property owned by Crossroads Youth Works on the north edge of Town that the Town was allowed to place a new welcome sign on.

Trustee Billmire moved to approve the Revocable License Agreement with Crossroads Youth Works, Trustee Nipple second; Mayor Fulmer called for discussion, none; motion passed.

Discussion on setting permit fee for temporary use storage container – code 7-7-4

Official Stegmaier stated that code 7-7-4 requires a permit to be pulled for the temporary use of storage container, but no fee is stated. After discussion, the Board set the permit fee at \$100 for 180 days. The applicant will need to request an extension after 180 days.

Trustee Nehl moved to approve the permit fee for temporary use storage containers of \$100 for 180 days and that an extension requested would need to be filled after 180 days, Trustee Nipple second, Mayor Fulmer called for discussion, none, motion passed.

Ordinance 363 – Adding a new section 1-9-11 to the Town Code of Simla concerning protection orders

Land Use Application – Variance – Commercial setbacks – Elbert County Road & Bridge

Clerk Taunton informed the Board that the Elbert County Road & Bridge had submitted an application for a variance for commercial setbacks for a lien too they are putting up.at 809 Ute Ave. The Board set a public hearing for the variance request for April 30, 2026, at 7 pm.

Administrator Rapp requested the Board consider waiving the fees as the County helps the Town out with road repairs.

Discussion on adding ordinance to code regarding the width of streets, avenues and alleys.

Official Stegmaier stated there was an ordinance at one time regarding this issue but is no longer in the Code book. It was stated that encroachments are hard to enforce without an ordinance on these widths. It was also discussed creating a driveway standard; no action was taken on creating driveway standards. Public Works Director McCune stated he does have a map that states that streets are 80', avenues are 60' and alleys are 20'. The Board agreed to have the Town Attorney draw up an ordinance with these widths.

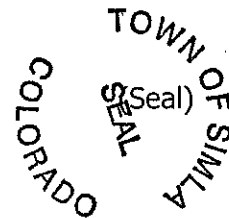

CHIEF KISSAM'S REPORT

Calls for service, proactive calls and traffic enforcement increased as expected for the month of March with a total of 341 calls being created for the department. We are seeing an increase in citizen assists due to the new Automated Speed Enforcement system. Town administration has assisted with these calls to ensure Dispatch isn't over loaded. Of the 341 calls created through dispatch, 253 were traffic stops.

Officer Knutsen is nearing the end of her FTO program and is expected to complete the program on time. She has assisted in many of our large cases and has had the opportunity to act as primary on multiple.

Officer Allen and I completed the mandatory 40-hour Basic School Resource Officer (SRO) Training in Highlands Ranch. The Simla Police Department is now Statutorily compliant having two (2) trained School Resource Officers. We look forward to partnering with the Big Sandy School district soon to implement what we've learned from our training.

We have taken a small step towards implementing our new summer shift schedule. You will notice officers out later in the evening as we try to remain visible to increase traffic safety and reduce the amount of crime in the area.

The Simla Police Department will continue its efforts to provide professional, proactive, and community-focused policing while adapting to the needs of the town as we move into the coming months.
