Richard Sandstead -

Citizen Richard Sandstead came before the Board to get clarification on the additional costs he was told he needed to pay, above the tap fee he paid, to have a new water service connected. Public Works Director McCune stated he needs to purchase materials for the installation. Town Administrator Rapp stated that the staff will need to verify when the ordinance went into effect and get back with Mr. Sandstead.

Attorney Report

Administrator Rapp stated the Town was approved for a \$10,000 grant from DOLA that will be used to pay for the water system study. Administrator Rapp had a meeting with Big Sandy School Superintendent Mr. Robinson to discuss the cost share agreement the Town has with the school district regarding the

football field. They will be working on drafts of the revised agreement so each respective board and legal counsel can review. There were no questions from the Board for Administrator Rapp.

Director McCune presented to the Board that citizen Liz David would like to keep her water running again this winter, due to freezing issues she had last winter. Trustee Nehl stated that Town had done work to raise the road back up and that there should not be an issue with the water line freezing before the meter. The Board stated that the Town would not be providing credit for any water used over the normal allotted gallons per month if she chose to keep her water dripping. Director McCune stated that he was given a 4 month time frame for the Town to receive the water system report being done by Element Engineering. NEW BUSINESS

Discussion and Action: 2026 Trash Vendor Bid Review and Vendor Approval

Clerk Taunton presented to the Board the 3 bids that the Town received for 2026 trash service, HBS Trash Service, Iron Knight Disposal, and LPS Waste Solutions. Representatives for Iron Knight and LPS were present. Questions were asked by the Board to each company's representative.

Trustee Nehl moved to award the 2026 trash service bid to LPS Waste, Trustee Ivanovic seconded; Mayor Fulmer called for discussion, Trustee Billmire stated he would like to go with someone more established, Trustee Nipple stated she understands the struggle of an upcoming business and someone has to take a chance on a new business. Administrator Rapp had Mr. Lally confirm his financing is sold; he stated it was but that he will not be moving forward with starting the business without the Town's contract. Administrator Rapp stated that the Town must have consistency. Administrator Rapp stated that we must have a backup plan for trash service. Mayor Fulmer requested a roll call: Trustee Billmire – no, Trustee Ivonavic – yes, Trustee Nehl – yes, Trustee Nipple – yes, motion did not pass. Trustee Billmire asked for a second to think, there was a revote taken, Mayor Fulmer asked for roll call, Trustee Billmire – yes, Trustee Ivoanovic – yes, Trustee Nehl – yes, Trustee Nipple – yes, motion passed.

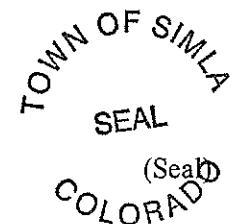

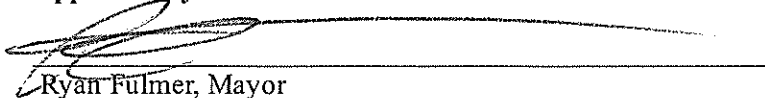
