Approval of Prior Meeting Minutes:

Audience to Visitors:

Todd and Sarah Lally with LPS Trash Services came before the Board to discuss trash service their company is contracted with Town for. They had questions regarding their contract and issues with citizens putting out more trash than they were being billed for. Town Administrator Rapp stated that is the responsibility of the trash contract to notify citizens if they are putting out more trash than they are billed for or are putting out trash that cannot be taken to the land fill. Lally Trash Services are to notify Town Hall if a citizen needs to have additional charges placed on their monthly trash bill.

Town clean up day was set for June 27th.

Attorney Report

Mr. Parikh stated he had nothing to add.

Town Administrator Report

Administrator Rapp notified the Board that Element Engineering had completed the report on the Towns water system. She suggested a date for a workshop be set for Element Engineering to present to the Board. After discussion, May 19th or May 20th would work for the workshop. Administrator Rapp will check with Element on what day will work for them. Administrator Rapp presented bids that were received to construct new bathrooms at the park. After discussion by the Board, it was decided that the Town would act as the general contractor and put out bid requests for each stage of the building. The Board also agreed to ask the community for volunteers to help with the project.

Clerks Report

Clerk Taunton notified the Board that the building at the small park was tested for asbestos, which came back positive. An abatement company had provided an estimate of roughly \$38,000 for the abatement and to take the structure down. Town Administrator Rapp is working on submitting a grant application to cover the cost of the abatement and structure removal. There were no questions from the Board for Clerk Taunton.

Building Official/Code Enforcement – in packet

Chief Kissam was not present.

Public Works - in packet

Director McCune stated he had priced sensors for the sewer system. They cost roughly \$6,000 a piece. The Board stated that with yearly maintenance of the system, they did not think sensors were needed. Director McCune said the Ford pickup needs to have the front end rebuilt, an estimate of around \$4800. After discussion it was decided to see if the school auto shop would work on it. April was a highly productive month for the Simla Police Department, with a total of 315 calls for service generated. Our Traffic Division made contact with 243 drivers for violations ranging from minor infractions to misdemeanor traffic offenses. In total, 147 citations were issued, and 17 misdemeanor traffic offenses resulted in court summons. Excessive speeding and failure to stop at stop signs remain the most common violations. Despite implementation of the AVIS system, we have not yet seen a reduction in speeding-related offenses.

During April, 16 cases were opened. Currently, all investigative resources are assigned to case 26SP-0880, involving a reported sexual assault on a child. Remaining cases will be addressed according to priority and severity.

The department has successfully completed the implementation of Taser 10 devices. Officers and Code Enforcement personnel have completed and passed all required training to deploy this less-lethal tool.

Our department remains committed to traffic safety and will maintain a visible presence seven days a week during the busy season. Two officers will continue dedicated traffic enforcement assignments, while the remainder of the department focuses on ongoing investigations.
