

CHIEF KISSAM'S REPORT

February was relatively slow overall, with a total of 54 calls for service. Illness, mandatory Standardized Field Sobriety Testing (SFST) training, and Field Training for our new officer reduced our presence on Highway 24 and in the school zone this month. We will increase our visibility on Hwy 24 in March.

Our new officer will begin transitioning into a solo role “while under supervision” as part of her Field Training Officer (FTO) program this month. With spring approaching, we anticipate an increase in travelers on Hwy 24. Historically, higher traffic volume results in a corresponding increase in traffic violations, and we will adjust enforcement efforts accordingly.

We were also able to purchase two 2017 Dodge Ram Police Trucks from the Elbert County Sheriff's Office at a very generous price of \$10,000 per vehicle. We anticipate placing these units into service in mid-March. At that time, we plan to sell two Ford Explorers that have reached the end of their usable service life within the department.

Following these changes, our fleet will consist of:

- 3 × 2017 Ram 1500
- 3 × 2017 Ford Explorer
- 1 × 2018 Ford Expedition (transferred to Building and Code)
- 1 × Armored Truck

We remain committed to maintaining a visible and proactive presence within the community while responsibly managing department resources. As we move into the busier spring season, our focus will continue to be on traffic safety, community engagement, and effective service delivery.
