

## Town of Simla Summer Swim Bus Authorization, Medical Release and Parental Consent Form for 2018

(I)(We) hereby give our consent and authorization for our child(ren) to ride the bus provided by the Town of Simla for transporting our child or children from the Town of Simla to the Lion Municipal Swimming Pool and back to the Town of Simla.

(I)(We) further acknowledge and agree that the following conditions, rules and regulations shall be in full force and effect at all times concerning our child's transportation on the bus:

1. Before the bus will leave Simla for the trip to Limon, there must be at least ten (10) children wishing to take the bus. If there are not at least ten (10) children available to take the trip, that trip will be cancelled and it will be **the parent's responsibility to see** that the child returns to his or her home.
2. Unless the parent has made arrangements **prior** to the bus leaving Simla for the trip to Limon, the child will return on the bus from Limon to Simla after swimming is over with **no exceptions**.
3. Parents shall be responsible for assuring that the child is at the departure point on time and for assuring that the child is supervised or accounted for when the child is returned to Simla.
4. **The following rules shall be followed by the child when he or she is on the bus:**
  - A. **Follow directions the first time they are given.**
  - B. **Stay properly sited at all times, keeping hands, feet, and objects to yourself.**
  - C. **Swearing, unacceptable language, rude gestures, and loud noises are not permitted.**
  - D. **Be courteous and respectful.**
  - E. **Do no litter, write on, or damage the bus in any way.**
  - F. **No child may leave the Limon Swim Pool.**
  - G. **Child(ren) must follow the rules of the Limon Pool.**

5. If the above rules or any written additions thereto are not followed, the parents will be notified. Parent can be called to come pick up their child(ren). Sanction will include the suspension of the child's bus riding privileges for the rest of the summer. The parent acknowledges and agrees that riding the swim bus is a privilege and that no child will be allowed to make the bus ride unsafe or unpleasant for the driver or other children. Child(ren) reported as not being courteous and respectful to the Limon Swim Pool employees or disregarding swim pool rules will receive the same sanction of suspension of bus riding privileges.
6. (I)(We) acknowledge that the Town of Simla is not responsible for the behavior, activity, or safety of the child when the child is at the Limon Municipal Swimming Pool and the only transportation to and from the pool is being provided. The parents will not hold liable the Town of Simla, its agents or employees, for any accident or injury that might occur once, the child is at the pool.
7. Notwithstanding (my)(our) waiver of liability as set forth in paragraph 5 above, (I)(We) do hereby give our permission to the Town of Simla, its agents or employees, to obtain emergency medical treatment for our child as may be deemed necessary for the physical well being of our child(ren) by the agent or employee.
8. **(I)(We) have discussed the bus rules with my child and we both understand the importance of each child's cooperation in order to preserve the safety of all students. I understand that failure to comply with the rules could result in a suspension of my child's privilege.**
