Trustee Thieman moved to accept the Treasurer's report, Trustee McCune seconded motion passed unanimously.

Report:

Attorney Stan Kimble

Attorney Kimble proposed two ordinances for the board to approve. Ordinance 321 Storage Container Ordinance, and Ordinance 322 age of Manufactured homes. Attorney Kimble also presented a Lease Agreement and Resolution regarding Rod Webb leasing town property referred to as Apache Avenue located between Block 25 and 32 the original town of Simla, Elbert County, Colorado.

Chief Schiefelbein requested that while Attorney Kimble was still at the meeting if the board could address 1102 Liptrap. Linda Grant joined in by phone.
