The Mayor read an email from Steve Wilson Superintendent of Big Sandy School. The school is requesting that the town pay the cost of replacing the chain link fence at the baseball field, and putting crushed asphalt on the parking lot. Mayor Fulmer will contact Mr. Wilson and state that the town will have to have figures on how much the repairs will be, before the school purchases the items, once the town board receives the numbers they will inform the school if the board will pay.

The school also requested that the town pay 38% of the purchase price for the pump and the electrical work done at the football field. Trustee Thieman brought up the fact that the town board informed the school to get numbers before ordering pump, Mayor Fulmer will contact GMS to see if some of the contingency money from the water project could be used to pay for the pump and electrical. Trustee Billmire moved in an amended motion to pay for the project out of the contingency fund if allowed, Trustee Warnecke seconded motion passed unanimously.

Mayor Fulmer had a phone call from Mark Dettenrieder with Elbert County Economic Development regarding the town purchasing some property to develop. Mayor Fulmer will get some more information
