Kathleen Craun - feline spayed/neuter clinic

Katleen Craun came before the board to ask if they would help sponsor to have the feral cats spayed and neutered in Simla. It cost's \$20.00 per cat. Wild Blue would come to Simla trap spay and neuter the cats they trap.
